

optimized-routines Assignment Agreement v1.1

Thank you for your interest in the optimized-routines open source project, available at <https://github.com/ARM-software/optimized-routines> ("Project"). In order to clarify the intellectual property rights granted with Contributions and enable the Project or any part thereof to be contributed to and used by other open source projects, Arm Limited must have a signed assignment agreement on file from each Contributor. If Contributor agrees to be bound by these terms, complete the information below, sign, and send to optimized-routines-assignment@arm.com

- 1. Definitions:
a. Contributor means the person or entity identified below.
b. Contribution means any software, data, or other copyrightable materials, including any modification or additions, provided by Contributor to the Project, whether provided before, on or after the date of this agreement.
2. Contributor hereby agrees to assign and does hereby assign to Arm all copyright in Contributions.
3. Arm hereby grants back to Contributor a non-exclusive, royalty-free, perpetual, worldwide copyright license to Contributions for any use.
4. With respect to any patents or other proprietary interests that Contributor owns or can license without payment to any third party, Contributor hereby grants to Arm and recipients of the Project or part of the Project a perpetual, irrevocable, non-exclusive, worldwide, no-charge, royalty-free license to:
a. make, have made, use, sell, offer to sell, import, and otherwise transfer Contributions in whole or in part, alone or in combination with or included in the Project or any product, work or materials arising out of the Project to which the Contributions were submitted; and
b. at Arm's option, sublicense these same rights to third parties through multiple levels of sublicensees or other licensing arrangements.
This license provision will be binding on the assignees of or other successors to the patents or other proprietary interests.
5. Contributor agrees to not assert any moral rights in Contributions against Arm, our licenses, or transferees.
6. Contributor will, at Arm's request, execute all documents or do all acts as may be necessary to vest the rights or licenses as described in this agreement. Additionally, Contributor will, at Arm's request, assign or otherwise transfer any other related intellectual property rights as are reasonably necessary to enable the Project or any part thereof to be contributed to and used by other open source projects.
7. Contributor represents that:
a. each Contribution is an original work of authorship and Contributor can legally grant the rights set out in this agreement; and
b. to the best of Contributor's knowledge, each Contribution will not violate any third party's copyrights, trademarks, patents, or other intellectual property rights.
8. Contributor agrees to notify Arm if Contributor becomes aware of any circumstance which would make any of the foregoing representations inaccurate in any respect.
9. With respect to any Contribution that Contributor makes pursuant to this agreement, Arm agrees that Contributor may further contribute that same Contribution to the GNU C Library ("glibc," as maintained at <https://www.gnu.org/software/libc/sources.html>) provided that Contributor include an appropriate attribution to Arm's copyright in the Contribution upon contributing such Contribution to glibc.
10. This agreement is governed by the laws of the State of California and applicable U.S. Federal law. Any choice of law rules will not apply.
